### **FACTS/ISSUES:**

On March 18, 2013, Victoria Hunter tripped and fell over an uncovered City utility box in the sidewalk on International Boulevard near 96<sup>th</sup> Avenue. She suffered soft tissue injuries to her back, knee, ankle and shoulder. She sued the City alleging the city maintained a dangerous condition and sought \$4,900.00 in medical expenses and \$27,000.00 in lost wages. This settlement resolves all claims in this matter.

On June 24, 2014, Ms. Brigham tripped and fell in a roadway depression abutting a curb in front of 7103 International Blvd, injuring her ankle and back. She received chiropractic treatment and required crutches for several months and incurred over \$6,000 in medical expenses. This settlement resolves all claims in this matter.
